1. Membership year begins October 1. Full Annual Dues are payable from October 1 to September 30, regardless of date elected. Annual Dues may be paid monthly at member's option.

2. Age of member on October 1 determines class of membership.

3. Intermediate moving to Active receives credit for Intermediate initiation fee. Fee is waived if Active applicant has paid Intermediate dues for 5 years immediately prior to applying for Active Membership.

4. Junior moving to Intermediate receives credit for Junior initiation fee. Fee is waived if Intermediate Applicant has paid Junior dues for 7 or more years immediately prior to applying for Intermediate Membership.

5. Junior initiation fee is waived if parent is a member in good standing and application is made while applicant is age 16, OR if application is made by April of the year following the parents' election to membership.

6. ALL applicants, regardless of membership class, must have been introduced to a minimum of five (5) members of the CURRENT Board of Directors prior to election. It is the responsibility of the sponsor(s) to arrange the introductions. The Membership Director will be pleased to assist in arranging introductions.

7. Dues, initiation fees and annual assessments (if applicable) are subject to GST and HST.

8. Initiation Fees/Dues are stated in Canadian Dollars and remainder is to be paid upon admission to the Club.

9. Applicants agree to apply for membership(s) for all children over 16 years old or upon their becoming age 16 who will be using the Club on more than 3 occasions per year.
